Head Moderator's ReturnTown Hartford

The Democratic Head Moderator must make a duplicate of such return, sign both and *deliver one copy* of the returns to the Secretary of the State or to the State Police. The Head Moderator must either (1) fax one copy of the return to the Secretary of the State by 12:00 midnight on primary day and then send such return to the Secretary of the State not later than 3 days later (Friday, August 15, 2008) or (2) deliver immediately by hand to the Secretary of the State not later than 6:00 p.m. of the day after the primary or to the state police not later than 4:00 p.m. who shall then deliver by hand to the Secretary of the State before 6:00 p.m. such return. If the Head Moderator faxes the return to the Secretary of the State, he must also send the return by August 15, 2008 by mail or hand delivery. A late filing will make the Head Moderator liable for a late filing fee of \$50.00.

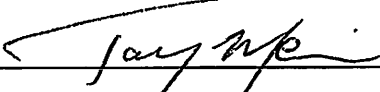

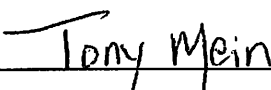
